RENEWAL OF EXPIRING REFERENDUM REVENUE AUTHORIZATION The School Board of Independent School District No. 695 (Chisholm Public Schools), Minnesota, has proposed to renew the existing property tax referendum authorization of \$251.38 per pupil which is scheduled to expire after taxes payable in 2023. The proposed referendum revenue authorization would be first levied in 2023 for taxes payable in 2024 and would be applicable for ten (10) years, beginning with taxes payable in 2024, unless otherwise revoked or reduced as provided by law.
